As per the Recruitment Rules, 2015 for "Tax Assistant" those officials have been appointed on "Compassionate Ground, Sports Quota etc. shall have to pass "Data Entry Skill Test" by making not less than 8000 Keys depression per hour. Also, Group 'C' employees, viz., Notice server, Record keeper, existing MTS/ newly recruited and senior Gestener Operators with combined service of five years in group 'C' and 'D' are eligible for promotion to the post of Tax Assistant and such employees have to pass Data Entry Skill Test by making not less than 5000 Key depressions per hour.

In this connection, Data Entry Skill Test 2026 is scheduled to be conducted batch wise from **14.05.2026** (Morning & Afternoon Sessions) to **15.05.2026** (Morning & Afternoon Sessions) at MSTU, Aayakar Bhawan, Hyderabad. The schedule of skill test Examination is enclosed as per Annexure1 & 2.
