absence there from will be treated as dereliction of duty.

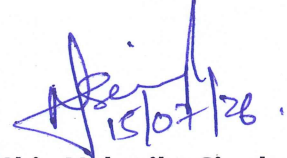
Even, if *any of the officials is under the orders of transfer* from the present office,

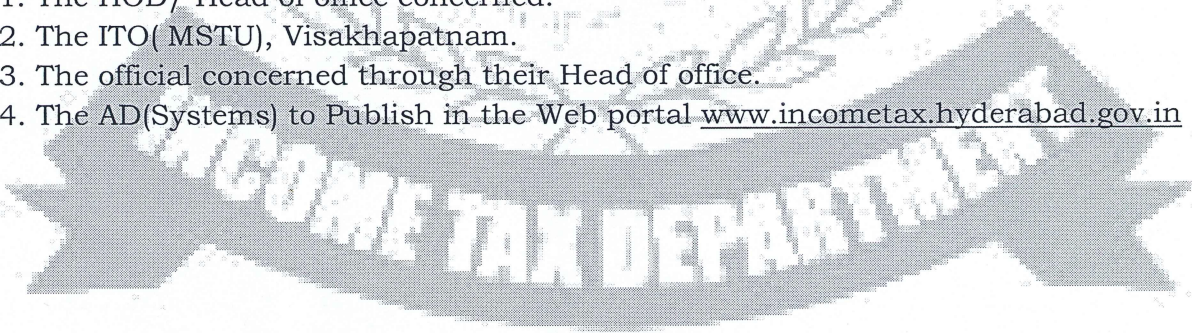
