- In case, any official is being proposed to be retained beyond the above-mentioned date, the Head of office shall take prior written approval from the Pr. CCIT, AP & Telangana.
- The Heads of Office are directed to send separate compliance report on relieving and joining of officials from/to their offices latest by **24.07.2026** to the ITO(HQ)(Pers.)(OSD), O/o. PCCIT, AP & TG, Hyderabad.
- Unless the transfer order is cancelled either suo-moto or on representation, before the due date of relieving the transferee shall be considered as deemed relieved on the due date given in the transfer order. It is clarified that representation made against the transfer

shall not confer any right whatsoever on the official to continue at the previous post in defiance of the transfer order. In view of this, if any of the Official is not relieved by due date, he/she shall be deemed relieved by next working day.
