FINAL MINUTES OF THE MEETING OF THE SCREENING COMMITTEE CONSTITUTED FOR THE PURPOSE OF APPOINTMENT ON COMPASSIONATE GROUNDS IN INCOME TAX DEPARTMENT, AP & TELNAGANA FOR V.Y.2022 HELD ON 12.09.2024, 19.09.2024 & 04.10.2024

The Screening Committee for examining and recommending the deserving applicants for appointment in the Department on compassionate grounds was constituted by the Principal Chief Commissioner of Income Tax, AP & Telangana, Hyderabad, vide order in F.No.Pr.CCIT/AP&TS/Estt/Comp.Appnt./2023-24 dated 24.07.2023 which was reconstituted vide modification orders dated 26.02.2024 & 20.06.2024. The members of the committee are:

- 2. The administration has informed the committee that the vacancies for filling up under compassionate appointment are **8**, for the vacancy year 2022. The administration placed before the Committee the applications for compassionate appointments in **73 cases**, along with enquiry reports and other details pertaining to Last Pay Drawn, pensions and Terminal benefits, etc.
- **3**. The Committee met on various dates including 06.09.2023, 31.10.2023, 12.05.2024, 03.08.2024, 12.09.2024, 19.09.2024 and 04.10.2024, all the committee members attended the meetings. The committee placed the minutes of meeting on the Public Domain i.e. @https://www.incometaxhyderabad.gov.in.
- 4. The committee has decided to put the cut-off date of 31.12.2022i.e. the applications filed till 31.12.2022, to be considered for screening, as the vacancy year under consideration for compassionate appointments is 2022. Accordingly, the applications received upto the cut-off date i.e. 73 applications were examined. Further, the administration also intimated about the 05 applications which were received after 31.12.2022. In this regard, the committee decided that these applications will be considered for vacancy year 2023 onwards. Further, with an aim to bring uniformity in evaluation of the applications under each parameter of the CBDT's 100-point formula, which is discussed in detail in the below paras, the committee decided to adopt cut-off date of 01.01.2024, wherever applicable, as committee gathered relevant information pertaining to applicants' family condition and need for assistance through Departmental enquiries conducted between 01.01.2023 to 31.12.2023, including information from ZAO (wherever necessary).
- The Committee perused the Scheme for Compassionate Appointment, 1998 issued by the DoP&T and the instructions on compassionate appointment, issued by DoP&T, vide its O.M.s in F.No. 14014/02/2012-Estt.(D), dated 16th January, 2013 and 07th October 2014 and subsequent clarifications issued from time to time including the latest DoP&T's OMs in F.N.43019/9/2019-Estt.(D), dated 23.08.2021 and Master Circular issued by the DoP&T vide O.M. in F.No.14014/1/2022-Estt.(D), dated 02.08.2022.The Committee has perused

Frequently Asked Questions (FAQs) on compassionate Appointment and answers of DoPT Establishment 'D' Division vide DOPT OM No. 14014/02/2012-Estt.(D), dated30-05-2013.

6. As the compassionate appointment is given to the family members of deceased government servant who are in financial distress, the applications for compassionate appointment are required to be considered keeping in view of the CBDT's 100 point formula in F.No.A-12012/09/2015-Ad.VIII, dated 08.04.2015. The said 100 point formula for assessment of applications has been modified vide letter of CBDT's in F.No.A-12012/03/2021-Ad.VII, dated 15.04.2021, which is as under:

- 7. The administration placed before the committee 73 applications which were received before the cut-off date i.e. 31.12.2022 and the list of applications is annexed to this report as **Annexure-A**.
- **8.** With regard to filling up of the 8 vacancies, the administration has given statistics of the cadres that will be filled through Direct Recruitment on compassionate grounds as tabulated under:

9. The administration has also informed the screening committee that the vacancies of ITI cannot be filled under the compassionate grounds vide CBDT's letter in F.No. A-12012/41/2003-Ad. VII(pt.), Dated. 13.02.2004. With regard to filling up of the vacancies in the cadre of Stenographers, it is pertinent to mention here that the applicants should have knowledge of shorthand or stenography. In this regard, the committee verified the 'skill of shorthand' amongst the applicants and found that none of the applicants possess skill of shorthand or stenography. As the recruitment rules do not permit the recruitment of applicants without the requisite skills, no applicant has been recommended for the post of Stenographer. Hence, the committee has duly recommended the applicants for 8 vacancies in the cadre of Tax Assistants (3)and Multi-Tasking Staff (5) as per the rank of the applicant in the CBDT 100 point scoring formula and educational qualification.

- **10**. The applications of the following **6** applicants have not been considered for recommendation for appointment under compassionate grounds:
- 10.1 Shri B. Gangadhar, S/o Late Shri B. Ram Prasad, OS, O/o Addl.CIT, Range-8, Hyderabad: There is dispute between two wives of the deceased official on their valid legal status as wife and consequently eligibility of their son as legal heir. Both of them have filed cases claiming their right as legal heir in CAT, and the decision is pending as on date. Further, the application has not been received through proper channel i.e. from the office where the deceased official last worked. The application may be considered in future once the dispute about legal heir is settled and the application is re-submitted through proper channel.
- 10.2 <u>Sri. Pureti Sriram, s/o Rajanala Sandhya Rani, ITO, O/o. ITO(IAP)-II,Hyderabad:</u> The applicant has withdrawn his application vide his letter dated 29.04.2024, therefore, his application was not considered for compassionate appointment.
- 10.3 <u>KumariK.V.Spoorthi Navya, D/o K.V.Narsing Rao, STA, Range-6, Hyderabad</u>: The applicant's D.O.B. is 06.07.2007, thus, she has not attained the age of 18, the minimum age for application for any post. The administration vide letter dated 22.11.2019 has communicated to the applicant's mother that she can apply for compassionate appointment for her daughter after she attains the minimum age required i.e. 18 years. In view of the above, the committee did not consider her application.
- 10.4 Smt.Kondapaturi Sandya Rani, w/o. Kondapaturi Yedukondalu, NS, O/o. ADCIT, Range-3(erstwhile),Vijayawada: The applicant vide her letter dated 14.06.2024 has requested for withdrawal of her application for compassionate appointment due to health issues and she has also requested for considering the application filed in her second son's name i.e. K Vijay Kumar instead of her application. The committee has considered her request for withdrawal and did not consider her application.

Further, the application dated 10.07.2023 filed by her son is received after the due date fixed by the committee i.e. after 31.12.2022, and hence, the same will be considered for the vacancy year 2023 onwards.

- 10.5 <u>Kumari Peddinti Sai Lakshmi, D/o Late Peddinti Appa Rao, NS, O/o ITO, Ward-1, Vizianagaram</u>: As per the report submitted by ITO, Ward-1, Vizianagaram (received through O/o. PCIT-1, Visakhapatnam), the applicant Smt.P Sai Lakshmi has withdrawn her application for compassionate appointment and her brother Sri. Peddinti Bunny Srinivas made fresh application for compassionate appointment on 03.07.2023. The committee verified date of application filed by Sri. Peddinti Bunny Srinivasand the same were found to be received after 31.12.2022 which is the cut-off date for considering applications for VY 2022. Accordingly, the same will be considered for the vacancy year 2023 onwards.
- **10.6** <u>Sri. Gadde Sai Krishna, s/o. Gadde Srinivas, TA, O/o.CIT(TDS), Hyderabad</u>: The applicant filed an application dated 04.07.2022 and the same could not be considered for the reason that he being a Minor had become ineligible to consider for appointment under compassionate grounds(D.O.B:11.02.2005). Subsequently, the applicant filed fresh application dated 12.12.2023. In view of the above, application of the above candidate can be considered for the vacancy year 2023 onwards.

- 11. The applications numbering 67 (other than those not considered as per above-mentioned Para-10) have been evaluated by allotting appropriate points as per 100 point formula devised by CBDT vide letter in F.No.A-12012/03/2021-Ad.VII, dated 15.04.2021. Hence, the committee duly following latest guidelines and master circulars on recruitment process under compassionate appointments, allotted points to all the 67 applicants who have submitted details as required.
- 12. As per the instructions of CBDT's letter in F.No.A-12012/40/2022-Ad.VII, dated 23.09.2022, the committee has followed the DoP&T's Master Circular on Scheme of Compassionate Appointment vide OM in F.No. 14014/1/2022-Estt(D), dated 02.08.2022. Accordingly, the committee has decided to communicate each applicant of their total earned merit points i.e merit points earned against each parameter along with total merit points earned and communicated the points vide letters dated 09.08.2024. The applicants, vide the aforesaid letters, were also requested to file their objections on the points awarded by the committee, if any, by 23.08.2024. In consequence, 19 applicants have filed their objections on the points awarded.
- **13**. In order to dispose of the objections received and make final recommendations, the committee decided to conduct a meeting on 12.09.2024. Accordingly, during the committee meeting held on 12.09.2024, the committee verified objections received from the following 19 applicants and the same are disposed of as under:

(i) N Ramesh Babu, s/o. N.Ayyanna, NS, O/o. IT Office, Kurnool.

(a) The applicant objected to the 'Zero' points awarded under the category "Family Pension" by stating that his family is getting 'NIL' pension. The committee verified the latest ITI enquiry report wherein it was reported that the spouse of the deceased employee, who was drawing family pension expired on 25.07.2023, thereby making the family ineligible to draw family pension (as there are no children below the prescribed age to draw the family pension). Hence, the committee awarded 'Zero' Points.

- (b) The applicant also objected to 'Zero' points awarded under 'immovable property/movable property' category by stating that the immovable property owned by his family is situated in a slum area which does not have proper Electricity and other amenities, and the value of property does not exceed Rs 4 to 5 lakhs. In this regard, the committee to arrive at the value of immovable property placed reliance on the Unit Rate list of the SRO for the particular location (copy placed on record) wherein the land was valued at Rs. 9,300/- per Sq Yard and the area of the house property is 120 Sq. Yds. Further, the committee also considered cost of construction to arrive at value of the Immovable property which exceeded Rs.20 Lakhs. Hence, the committee rightly awarded 'Zero' points under this category. Hence, the committee decided that no change is required in the points awarded.
- (c) The applicant also stated that his family is having debts/loans of Rs.21,00,000/- (in support, copies of promissory notes were attached). In this regard, the committee verified the promissory notes and observed that these loans were taken after death of the deceased employee and hence, the committee decided to take a uniform stand in all such cases by considering liabilities which were existing as on the date of death of deceased employee, for awarding points and not considering any fresh liabilities incurred after the death of the deceased employee. Further, the ITI in his enquiry report submitted that the liabilities of the family are 'NIL'.

Therefore, the committee decided that there would be no change in the points awarded in this case.

- (ii) P.Nishanth, s/o. Page Sheshu Rao, Store Keeper, O/o. CCIT-1,Hyderabad.
- (a) The applicant objected to '9' points awarded under the category "Family Pension" by stating that his family gets monthly pension of Rs.14,000/- only. In this regard, the committee obtained latest information about family pension being disbursed to applicant's family, and ZAO furnished information wherein it was found that the basic family pension of pensioner was revised to Normal Rate w.e.f 21.12.2022 to Rs.10,590/-. Hence, the committee decided to award '13' points instead of '9'.
- (b) Further, the applicant objected to 'Zero' points awarded under 'Movable/Immovable property' category and stated that his family sold the house property, due to financial difficulties and hence, the same may be considered for awarding points. In this regard, the committee decided to consider these properties under immovable /movable properties category only as these immovable properties remained unsold as on the date of death of the deceased employee. Further, the ITI enquiry reports available on record shows that the applicant's family still owns the immovable property. Therefore, the committee decided that there would be no change in the points awarded under this category.
- (c) The applicant also objected to 'Zero' points awarded under the category "Major Sons of deceased (Upto 25 Years)" and stated that at the time of his application, he was 22 years old, and his brother was 25 years old, and both of them were unmarried. In this regard, the committee decided to consider the age of the major sons as on cut-off date i.e.01.01.2024. Accordingly, the committee verified the records available and found that the ages of three sons are 41 Years, 35 Years and

- 33 Years respectively. Therefore, the committee decided that there would be no change in the points awarded under this category.
- (d) The applicant also objected to the 'Zero' points awarded under the category "Minor Children of deceased". In this regard, the committee duly adhering to the provisions given in the CBDT's 100 point formula, awarded 'Zero' points by not considering the Minor Children of applicant as the points are awarded for Minor Children of deceased employee only and not that of the applicant. Therefore, the committee decided that there would be no change in the points awarded under this category.

In the applicant's case, after considering the correction required in the points awarded under 'Family Pension' parameter, the total points of the applicant increased from '21' to '25'.

- (iii) Samalapurapu Mohana Siva Kumar, s/o. Samalapurapu Venkateswara Rao, NS, O/o. Addl. CIT, Kakinada.
- (a) The applicant objected to '2' points awarded under the category "Movable & Immovable Property" by stating that previous committee awarded '8' points whereas present committee awarded '2' points. As per latest enquiry report, the applicant and his brother have one plot each with an area of 56.88 Sq. Yds (each)and the ITI also submitted that SRO value of both the plots is around Rs. 8 Lakhs (SRO Value of land is Rs. 7,000/- per Sq Yd). In addition, the family owns gold against which loan of Rs. 6.3 Lakhs was taken(indicating that the value of gold owned is Minimum of Rs. 7 Lakhs). Accordingly, the total value of movable / immovable property exceeds Rs.15 Lakhs. Hence, the committee has awarded '2' points to the applicant on this parameter.
- (b) The applicant also objected to 'Zero' points awarded under "Annual Income" category while previous committee awarded '8' points. In this regard, the committee considered income of all earning members of the applicant's family as reported in the enquiry report of ITI wherein income from AC mechanic profession of the applicant and his brother exceeded Rs.2,00,000 per annum. As per the 100 point formula referred above, if the family income exceeds, Rs. 1.95 Lakhs, the point to be awarded is 'Zero'.

Therefore, the committee decided that there would be no change in the points awarded in this case.

- (iv) Y Sisir Snigdha, d/o. Y.David Benny Babu, Sr.PS, O/o. Pr. CIT, Guntur.
- (a) The applicant objected to '9'points awarded under "Family Pension" category instead of '15' points as arrived by the applicant citing the non-receipt of family pension. In this regard, ZAO has informed that the family pension to the applicant family was stopped only due to non-submission of required documents of eligible family member to draw family pension and hence, the contention of the applicant is not accepted.

(b) The applicant has also objected to 'Zero' points awarded under "terminal benefits" category. In this regard, the committee verified the total terminal benefits

received by the deceased employee's family stood at Rs. 53 Lakhs and hence, decided that there would be no change in the points awarded under this category.

- (c) The applicant objected to 'Zero' points awarded under "Annual Income" category. In this regard, the committee verified income of all earning members of the family from the ITI enquiry report which reported annual income more than Rs. 2 Lakhs. As per the 100 point formula referred above, if the family income exceeds, Rs. 1.95 Lakhs, the point to be awarded is 'Zero'. Hence, no change is required in the points awarded.
- (d) Further, the applicant objected to 'Zero' points awarded under "No. of dependents i.e. spouse or parents of the deceased employee" category. In this regard, the committee verified the submissions of the applicant and ITIs enquiry report and found that the committee has rightly awarded 'Zero' points as dependents of deceased employee i.e. spouse or parent of deceased employee are not alive.
- (e) The applicant objected to the 'Zero' points awarded under the category of "Years of service to be rendered in Govt. by the widow(in case widow is applicant)" category. The Committee verified the fact and found that widow of the deceased employee is not the applicant in the present case, and hence, concluded that it had rightly awarded Zero points.

Therefore, the committee decided that there would be no change in the points awarded in this case.

(v) J.Vijay Sai, s/o. J.Aravind Kumar, MTS, O/o. PR.CCIT, Hyderabad.

- (a) The applicant objected to 4 points awarded under "Terminal Benefits" category and stated that his family had received very less terminal benefits and the entire amount received, was spent for medical treatment of his brother, who met with road accident. In this regard, the committee verified the total terminal benefits received by the deceased employee's family which are more than Rs.20 Lakhs, and hence committee rightly awarded '4'pointsunder this category.
- (b) Further, the applicant objected to the '8' points awarded under the category "Movable / Immovable Property" category instead of '10' points. In this regard, the committee verified information available in the form of ITI enquiry reports, and found that there are movable / immovable assets worth Rs. 2.7 Lakhs in the name of applicant's family. Accordingly, the committee decided that no change is required in the points awarded.
- (c) The applicant also objected to '3' points awarded under "No. of unmarried Major Sons(upto 25 years)" category instead of '5' by stating that at the time of submission of application his brother's age was 21 and he was unmarried, hence requested to revise the points in this category. In this regard, the committee decided to consider the age of the major-sons as on cut-off date i.e 01.01.2024. Accordingly, the committee verified record available and found that the age of one of the major sons has crossed 25 years and hence, rightly award "3" points.

(d) The applicant objected to 'Zero' points awarded under "Additional Liabilities/Person with Disability" category, by stating that his brother met with an accident and is bed ridden till date and his left hand became disabled. In this regard,

the applicant was requested to submit the Disability Certificate of his brother in prescribed format. In response, only a medical prescription/declaration mentioning the details that the 'patient is not able to perform his duties' is furnished. As the said document is not in prescribed proforma, one more opportunity was afforded to applicant seeking to furnish the Disability Certificate issued by the Competent Authority (duly attaching the format of the prescribed proforma). However, the applicant failed to produce the required certificate. Therefore, there will be no change in the points awarded by the committee.

Therefore, the committee decided that there would be no change in the points awarded in this case.

(vi) Arani Kantha Lakshmi, D/o. Arava Arya Das, NS, O/o. JCIT, Nellore. The applicant objected to 'Zero' points awarded under "No. of Dependent Minor Children" category. In this regard, the committee duly verified CBDT's 100 point formula and found that it has rightly awarded points by not considering the Minor Children of applicant as the points are awarded for Minor Children of deceased employee only.

Therefore, the committee decided that there would be no change in the points awarded in this case.

- (vii) Tirumalasetti Swathi, w/o. Late Sri.Tirumalasetti Srinivas, ITI, O/o. ADCIT,Range-5,Visakhapatnam.
- (a) The applicant objected to 'Zero' points awarded under "Basic Family Pension" category. In this regard, the committee verified submissions of the applicant and found that the same are not tenable as the eligibility of the applicant is being decided on the present factual basis and not on the basis of pension to be received in future i.e. after 5 years. Therefore, the committee decided that there would be no change in the points awarded under this category.
- (b) The applicant also objected to 'Zero' points awarded under "Movable Property /Immovable Property", category. In this regard, the committee verified submissions of the applicant and held that the applicant's claim to increase the points as the immovable property acquired on a Bank Loan of 30 years tenure on EMI basis, cannot be accepted due to the fact that the said property has been purchased by the applicant which was duly registered on her name. Further, the family of applicant is staying in the immovable property purchased. Hence, the committee considering the SRO value of said immovable asset, rightly awarded Zero points under this category. Therefore, the committee decided that there would be no change in the points awarded in this case.

(viii) Shubham, s/o.Late Smt. K.Rajkali, MTS, O/o. CIT(IT&TP), Hyderabad. The applicant objected to 'Zero' points awarded under "Additional Liabilities" category by stating that his family has taken bank loan and requested to consider the said loan for awarding points under additional liabilities category. In this regard, the committee on verification of documents produced found that the said loan/liability is

in the name of Ranjeeta who is a married daughter of deceased official, thereby not forming part of applicant's family. Moreover, the committee observed that the said loan was acquired after the death of deceased employee.

Therefore, the committee decided that there would be no change in the points awarded in this case.

Doundhay Meena, s/o.Doundhay Satyanarayana, MTS, O/o. Addl. CIT(central), Range-2, Hyderabad. The committee verified submissions of the applicant and found that he has made generalized submission on the total points awarded duly informing that his family does not own any immovable property and he alongwith his 3 children are fully dependent on his mother's family pension. In this regard, the committee verified the ITI enquiry reports available on record and found that the applicant's family owns 20 grams of jewellery alongwith a residential property worth market value of Rs.12,16,000/-. Moreover, the applicant in his application dated 12.11.2020, filed for compassionate appointment, mentioned the owner of the house as D Anasuya, mother of the applicant. Keeping in view that even if the immovable property is sold, these properties would anyway get converted into cash/bank balance, thus, duly becoming movable property falling under the same category of CBDT's 100 point formula i.e. 'Immovable / Movable property' category and hence, considered the value of said property to award points under this category.

Therefore, the committee decided that there would be no change in the points awarded in this case.

- (x) Valeru Balakrishna, s/o. Valeru Anjaneyulu, NS, O/o. ITO, Ward-1, Narasaraopet.
- objected to '8'points awarded under "Immovable applicant (a) Property/Movable property" category by stating that the applicant family does not have any fixed assets, movable or immovable properties and their family sold the gold of 1.5 tulas (sale receipt enclosed). In this regard, the basis for the points awarded by committee was perused and observed that as per the enquiry report submitted on 28.05.2024 & 19.12.2023, the movable/immovable properties owned by the applicants' family are 'NIL', however, as per the enquiry report dated 09.08.2021, 1.5 tulas gold was owned by the applicant. Further, as per the committee's uniform stand that the properties existing as on the date of death of deceased employee are required to be considered for awarding points, the applicant was rightly awarded with '8'points in this category. Therefore, the committee decided that there would be no change in the points awarded under this category.
- (b) The applicant also objected to 'Zero' points awarded under "Additional liabilities" category by stating that that his mother took loan of Rs.8,80,000/- from Credit Society and also took personal loan of Rs.3,46,000 from SBI. Further their family also borrowed money of Rs.8,00,000/- from other family friends and known persons for family expenses and educational expenses. In this regard, the committee primarily verified the document produced in support of loan sanctioned to the tune of Rs.8,80,000/- by the Credit Society in the name of applicant's mother and it is observed that it does not contain date of loan sanction. Further, with regard to loan

of Rs.3,46,000/- the narration for the entry in the bank statement is not clear about the fact that the amount credited is against the personal loan taken from the SBI Bank and the applicant also could not produce loan sanction document issued by the SBI. With regard to Rs.8,00,000/- loan borrowed from family friends and known persons, the committee observed that these loans were taken by the applicant family after the death of deceased employee and hence, the committee decided to take similar stand on the fact that the loans taken after the death will not be considered for awarding points. Further, as per the latest ITI enquiry report dated 19.12.2023, the additional liabilities of the applicant's family were reported as 'NIL'.

Therefore, the committee decided that there would be no change in the points awarded in this case.

- (xi) Vedururi Praveen Kumar, Vedururi Tirupataiah, NS, O/o. ADCIT (Exemptions), Vijayawada.
- (a) The applicant objected to 'Zero' points awarded under "Family Pension" category. In this regard, the committee verified the latest ITI enquiry report wherein it was informed that the spouse of the deceased employee, who was drawing family pension expired on 20.01.2023, and all other family members are ineligible to draw family pension due to their age. Accordingly, committee decided to award 'Zero' points as the family lost its eligibility to draw family pension as on the cut-off date.
- objected 'Zero' points also to applicant (b) The "Movable/Immovable Property" category as against 4 points awarded by earlier committee, by stating that one of the immovable properties, which is being used for residential property, does not hold any market value as it is situated on a hilly area and the other property will have market value of Rs. 9,00,132/- (SRO Certificate enclosed) and hence, the applicant requested that the points awarded may kindly be revised. The committee verified the ITI enquiry reports available on the record which shows the value of immovable property as more than Rs. 10 Lakhs. Further, the committee after considering the value of LIC Policy awarded Zero points under this category. However, the committee re-verified the factual position and decided to award 2 points as the value of immovable property(including LIC premium paid by the applicant towards LIC policy) exceeded Rs. 15 Lakhs. Hence, the points awarded under this category were revised from "0" to "2".
- (c) With regard to applicants' objection on 'Zero' points awarded under 'Dependents on Deceased Official' category against the '5' points awarded by the previous committee. The present committee verified the fact and found that the spouse of the deceased employee expired on 20.01.2023 and accordingly, awarded 'zero' points in this category.
- (d) The applicant also stated that out of the total loan taken of Rs.5,58,024/- an amount of Rs. 2,58,984/- is still pending to be paid. Moreover, the applicant submitted that he has additional responsibilities of maintaining his sister's family and hence, the applicant requested the committee to award merit points considering the additional burden on him. With regard to additional liabilities, it is observed that the loans were taken after the death of deceased employee and hence the committee decided to award 'Zero' points. With regard to sister's responsibility, no points can be awarded as per CBDT's 100 point formula.

In the applicant's case, after considering the correction required in the points awarded under 'Movable / Immovable property' parameter, the total points of the applicant increased from '16' to '18'.

(xii) Bandarapu Satish, s/o. Bandarapu Chandraiah, MTS, O/o. ITO(MSTU), Hyderabad.

- (a) The applicant objected to '2' points awarded under "Annual Income" category by stating that he is working as a car driver which is a seasonal work and presently, he is staying at home since last 3-4 months as there is no employment for him. The committee verified the submissions of the applicant with the information available i.e. from the latest ITI Enquiry report dt 25.09.2023, wherein the income of the applicant from the Driving profession was reported at Rs.1,92,000/- per annum. Hence, the committee as per its uniform stand, considered ITI report and awarded '2'points under this category.
- (b) The applicant objected to 'Zero' points awarded under Additional liabilities category, the committee verified applicant submissions and ITI report available onthe record and found that the liabilities occurred after the death of deceased official. Hence, the committee decided to consider additional liabilities as on the date of death only and not the liabilities arising after the death of the deceased employee. Moreover, the applicant did not furnish any documentary evidence in support of his claim for liabilities. Further, ITI reported liabilities in this case as NIL. In addition, the applicant also stated that he is having additional responsibility of his sister and her children. With regard to sister and her family's responsibility, no points can be awarded as per CBDT's 100 point formula.

Therefore, the committee decided that there would be no change in the points awarded in this case.

(xiii) Jagga Prashanth, O/o.Jagga Rajalingam, NS, O/o. ADCIT, Range-3, Hyderabad.

- (a) The applicant objected to the '2'points awarded under "Terminal Benefits" category. In this regard, the committee verified the record for receipt of total terminal benefits by the deceased employee's family and found that the total amount of terminal benefits received are more than Rs. 23 Lakhs. Accordingly, the points were rightly awarded by the committee in this category.
- (b) The applicant also objected to the '4' points awarded under "Movable Property/Immovable property" category. In this regard, the committee verified the records available and found that the applicant himself admitted that the house property (30 Sq Yards), where his family is currently residing, was originally allotted by the Govt of AP on 21.06.1967 and is presently registered on his grandmother's name. In this regard, the applicant in the succeeding para of his letter submitted that there are no immovable properties in the name of his father which appears contradictory as the committee has to consider all the immovable properties existing in the applicant family members' name. In this regard, the committee also verified latest ITI enquiry report wherein it was reported that the applicant's family is staying in their own house (which is an ancestral property). Further, the applicant in the

application dated 19.08.2021, filled for compassionate appointment, mentioned one asset as self occupied. Hence, the committee considering the SRO value of the said immovable property of Rs.10,24,000/-,and awarded '4'points under this category. Hence, there would be no change in the points awarded under this category.

(c) The applicant also objected to '6' points awarded under "Annual Income" category. In this regard, the committee verified with CBDTs 100 point formula wherein total income of all earning members of the family is to be considered and accordingly, awarded '6' points by considering the income reported in the enquiry reports available on record. In this regard, the committee also observed that the applicant has clearly mentioned in his application of the fact that his brother J Mahesh Babu is working as a Delivery Boy in Amazon with a monthly income of Rs.10,000/-.

Therefore, the committee decided that there would be no change in the points awarded in this case.

(xiv) Mohd Asif Ali, Mohammed Saheb Ali, NS, O/o. ADCIT, Karimnagar Range, Karimnagar.

- (a) The applicant objected to the 'Zero' points under "Immovable Property/Movable Property" category by stating that he was awarded with "6" points in this category by previous committee and as per the latest communication of points he was awarded "0" points only. In this regard, the applicant also submitted that his family constructed a small house on the plot that was purchased by his father, when he was alive. In this regard, the committee relying on CBDT's 100 point formula and also information available in the form of enquiry reports of ITI, decided to consider SRO value of the property reported by the ITI and accordingly arrived at the fact that the SRO value of movable/immovable property is exceeding Rs. 20 Lakhs. Therefore, it is opined that there would be no change in the points awarded under this category.
- (b) The applicant also objected to '3' points awarded under "No. of Unmarried Major Sons (up to age 25)" category by stating that the points awarded by previous committee were "5" and as per present committee, the points are "3". In this regard, the committee verified age of the elder son of the deceased employee, namely Mohd Asif Ali and found that he has completed 25 years on 21.08.2022 and he crossed 25 years as on the cut-off date adopted by committee i.e. 01.01.2024.

Therefore, the committee decided that there would be no change in the points awarded in this case.

(xv) Bodhanampati Nanda Gopal, Bodhanampati Veeraiah, NS, O/o. JCIT, Range-1, Vijayawada.

(a) The applicant objected to '8' points awarded under the category of 'Movable/Immovable property' stating that previous committee awarded '10' points. In this regard, the applicant submitted that the immovable property of vacant site of 48 Sq yards was actually allotted by State Govt as part of scheme for housing (under Navaratnalu Scheme) for weaker section and the allocation was made in his wife's name. However, the applicant made another contradictory submission that he does

not own any house or immovable property. Hence, from the aforesaid lines it is understood that applicant is making contradictory statements. In this regard, the committee relied on the information provided in the ITI Enquiry report dt 25.01.2022 and also on the applicant's admission that his wife was allotted with a vacant land of 48 Sq Yards. Hence, the committee considered the SRO Value of the property at Rs. 1,65,460/-, and accordingly, the committee has rightly awarded '8' points under this category.

- (b) The applicant objected to 'Zero' points awarded under the category of 'Annual Income' stating that previous committee awarded '4' points. The applicant stated that the auto rickshaw owned by him under EMI does not yield any income to his family as he gets Rs.15,000/- per month out of which he makes payment of Rs. 5,200 towards EMI, Rs.7,000/- towards Diesel and Rs. 3,000/- towards repairs of the Auto. Hence, the net income becomes Zero from his profession. Hence, the applicant requested that the points awarded may be revised as previous committee awarded '4'points in this category. In this regard, the committee considered the latest enquiry report dated 05.10.2023 wherein it was reported that income of the applicant was Rs. 18,000/- per month. Hence, the claim of the applicant cannot be accepted.
- (c) The applicant objected to 'Zero' points awarded under the category Additional liabilities; the committee observed that the majority of loans were taken post death of deceased employee. Further, the committee also verified with ITI enquiry reports wherein it was reported that the liabilities of the family are 'NIL'.

Therefore, the committee decided that there would be no change in the points awarded in this case.

(xvi) Rajolu Nagamani, s/o. Sirasapalli Srinu, Sweeper, O/O PCIT, Vijayawada.

- (a) The applicant objected to '8' points awarded under the category 'Annual Income' instead of '10' points claimed by her. The applicant submitted that her family is not earning any other income except for family pension. The committee decided to consider the latest enquiry reports dated 09.10.2023 & 12.01.2022, wherein annual income of the applicant is Rs.36,000/- and income of her mother Smt. Shyamala is Rs. 26,625/-. Accordingly, the committee has rightly awarded '8'points to the applicant considering income of all earning members of the family.
- (b) With regard to 'Zero' points awarded under Additional Liabilities category, the applicant submitted that her family is having liabilities of Rs. 6,00,000/- which were borrowed to meet family medical expenses due to ill health of family members. In this regard, the committee verified latest ITI enquiry reportdt09.10.2023 wherein it was reported that the liabilities of the applicant are NIL. Further, the Committee also verified the date of loans accepted through promissory notes and the same are dated 25-08-2020 (for Rs. 2,50,000/-), 18-09-2020 (for Rs. 2,00,000/-) and 27-06-2023 (for Rs. 1,50,000/-). In this regard, the committee took uniform stand in all such cases that the loans taken post death of deceased employee (i.e. DOD:27-08-2020, in this case) shall not be considered and also these are not declared/disclosed in the

application for compassionate appointment (i.e. as on 30.11.2021, the applicant declared liabilities as "NO").

Therefore, the committee decided that there would be no change in the points awarded in this case.

(xvii) Balda Jeevan Sai, s/o. Bandaru Shekar Babu, Ns, O/O Addl.CIT, Central Range-2, Hyderabad.

- (a) With regard to '3' points awarded under Left over service category, the applicant submitted that his father's left-over service was more than 9 years as the date of birth of his father was 30.10.1970 and date of expiry is 28.10.2021. In this regard, the claim of the applicant that date of birth of deceased father is 30.10.1970, was verified with the documents available on record including date of Birth entered in the Service Register of the deceased employee and found to be correct. The committee also verified the basis for '3' points awarded earlier and found that the year of Birth of '1969' available on Aadhar Card was previously considered by the committee. Now, the committee considering the actual DOB as per the Service record computed the left-over service of the deceased employee at 9 years 2 days. Hence, the committee awarded 4 points in place of '3' points.
- (b) The applicant objected to the 'Zero' points awarded under additional liabilities as the applicant submitted that his family is having liabilities of Rs. 6,00,000/- in the form of gold loan alongwith loans of Rs. 8 lakhs more from outsiders as well. In this regard, the committee verified the submissions of the applicant and found that applicant did not attach copies of loan documents to arrive at date of loan sanctioned/loan acquired. Further, the committee also verified the ITI enquiry report dated 12.10.2023 which revealed that the liabilities of the applicant are 'NIL', and hence, the liabilities disclosed now appear to be not genuine. Further, the committee verified the application filed for compassionate appointment dated 07.03.2022, wherein the applicant left the liabilities column as 'BLANK'. Therefore, it is decided that there would be no change in the points awarded under this category.

In the applicant's case, after considering the correction required in the points awarded under 'Left-over Service of deceased official' parameter, the total points of the applicant increased from '39' to '40'.

(xviii) CH. Soundarya Devi, d/o. Late. Sri. P Satyanarayana, NS, O/O ITO, Ward-1, Palakol. As the applicant did not have any objection on the points awarded, and merely made an elaborated submission about her family situations including health issues, the same were considered by the Screening Committee and found that these facts are general in nature which will have no effect on the points awarded.

Therefore, the committee decided that there would be no change in the points awarded in this case.

(xix) Bommala Sai Ajay, Bommala Krishna Prasad, Ns , O/O.Addl. CIT(TDS), Vijayawada.

- (a) The applicant objected to 'Zero' points awarded under additional liabilities category, the applicant submitted that debts of Rs. 15 Lakhs were already intimated to the Department vide his application for Compassionate Appointment dated 23.03.2022. Further, the applicant also submitted that debts of Rs. 26.50 Lakhs were added for meeting some personal expenditure like sister's marriage, her pregnancy expenditure, and other family expenditures. In this regard, the committee verified with the ITI enquiry report dt 25.09.2023 and noticed that applicant's family is having top up loan on house purchased on 29.09.2021 of Rs. 21,90,000/-, alongwith personal loan of Rs. 3,34,694/- from Kisestsu Saison Finance in May 2022, and another loan on 29.04.2022 of Rs. 1,29,649/- from IDFC First. The committee, considering its uniform stand on all such liabilities which were acquired post death of employee, decided that the liabilities of the applicant's family cannot be considered for awarding points.
- (b)The applicant also submitted few facts about his family background wherein it was stated that his mother is a house-maker and wholly dependent on family pension. Further, the applicant's family performed elder daughter's marriage in the year 2021 by taking debts. The applicant is also in search of a good job at Vijayawada. The applicant also stated that 4 years have elapsed since his father's death and his family is in dire need of employment in the Department. The committee has considered the facts quoted by the applicant and found that there would be no material effect of the said facts on the points awarded.

Therefore, the committee decided that there would be no change in the points awarded in this case.

RECOMMENDATIONS OF THE COMMITTEE:

15. Based on the findings and relevant information available, the committee has finalized its recommendations for candidates eligible for appointment on compassionate grounds. This decision follows a thorough evaluation of applicants using the prescribed CBDT 100-point formula. The process involved addressing objections from applicants and carefully considering the eight vacancies for Tax Assistants and Multi-Tasking Staff, in line with the required educational qualifications of graduation and matriculation/SSC, respectively. For considering a particular eligible candidate for the post of TA/MTS, his/her rank in the list of points table (given at para-14) is taken as basis, subject to fulfillment of minimum educational qualification i.e. 'Graduation' for TA post and 'SSC' for MTS post. As per the para 6.B of DoP&T OM on Master Circular on Scheme of Compassionate Appointment vide F.No. 14014/1/2022-Estt(D), dated 02.08.2022, upper age limit could be relaxed in the cases of compassionate appointments wherever necessary. Authority competent to take a final decision for making compassionate appointment shall be competent to grant relaxation of upper age limit also for making such appointment. It is, therefore, recommended that age relaxation may be granted to these candidates, as their age as on the date of application, is above the limits prescribed.

- 17. In case any of the selected candidates do not join or are not selected for any reason, the vacancy/vacancies so remaining unfilled may be offered to the next eligible candidate in the points list arranged in the descending order in para '14' above.
- **18**. The Screening Committee suggests that the offer of appointment to the above-mentioned applicants be made only after obtaining attested copies of certificates with regard to age and educational qualification and on verification of original certificates. The offer of appointment is to be made purely on provisional basis and subject to submission of affidavit stating as follows:

1."I hereby declare that the facts given by me above are, to the best of my knowledge, correct. If any of the facts herein mentioned are found to be incorrect or false at future date, my services may be terminated."

2."I hereby declare that I shall maintain properly the other family members who were dependent on the government servant and in case it is proved at any time that the said family members are being neglected or not being properly maintained by me, my appointment may be terminated."
