c)His promotion as Staff Car Driver, Grade-1 is subject to the outcome of any cases pending before the Hon'ble CAT and Hon'ble Courts.



e) His seniority in the cadre of Staff Car Driver, Grade-1 will be liable to revision at any point of time, if any bonafide mistake is found with reference to any records.

f) The official will not be eligible for pay fixation consequent to this promotion in case of his pay has already been upgraded in the scale of Staff Car Driver under ACP/MACP Scheme.

g) The above promotion to the cadre of Staff Car Driver, Gr-I is on in-situ basis.


