	(v)	Requests for transfers to different stations/offices made in the EPTRPs circulated and that in the representations received as on date have been considered and stand disposed off with this order.


4. The Commissioners of Income tax / Directors of Income tax are requested to make necessary additional charge arrangements in respect of vacant posts lying under their respective charges.
