The main agenda of the Course is to educate the retiring officers/officials with regard to retirement benefits, CGHS benefits, Investment and Retirement Planning, Health management and fitness including Yoga, Pranayama and Meditation, Re-orientation – building new Identity – tackling emotional vicissitudes and post-retirement stress management.

3. The Principal Chief Commissioner of Income Tax (CCA) desires that the officers/officials sponsored for training should not apply for leave during this period. If any of the officers/officials has already applied for leave, he/she may suitably revise the period of leave so that he/she can attend the training, as the above mentioned training course is solely for the benefits of the officers/officials after retirement.

The officer/official who requires accommodation in the DTRTI, Hostel have to necessarily apply online **in advance (three days before arrival date)** by logging on to DTRTI website **www.dtrtibangalore.com** and click on **online hostel booking** option which will guide the user through the registration process. The DTRTI, Bangalore has introduced e-payments for Hostel rent through debit /net banking alongwith the regular existing cash payments facilities.

5. **The officers/officials who are nominated for the Training may note that unless there is communication from this Office regarding cancellation their nomination for the training courses, the officials should attend the Training Course invariably.**
