विषयSub: Establishment – I.T. Department, Hyderabad – *Promotion to the cadre of Stenographer Grade I [Erstwhile Stenographer Grade-II] on Regular basis – Vacancy Year 2024*(Vacancy period 01.01.2024 to 31.12.2024)[Level 6 of 7th CPC (Rs.35,400-1,12,400)– Allotment of officials – Reg.

The following officials, whose names have been approved by the Departmental Promotion Committee for promotion to the cadre of *Stenographer Grade I [Erstwhile Stenographer Grade-II] on regular basis* for the vacancy year 2024 (01.01.2024 to 31.12.2024) (Pay scale Rs. 35,400-1,12,400/ Level 6 of 7th CPC) **with immediate effect or the date of joining whichever is later** and such allowances as may be sanctioned from time to time, are allotted to the appointing authority mentioned in column number – (3) for being posted in the office mentioned against his name in column number – (4) of the table below:

The respective Controlling Authority, under whose charge the official is presently posted shall issue the promotion order immediately and endorse a copy thereof to this office. The date of joining of the Official shall be intimated to this office by respective CCIT/DGIT/PCIT/PDIT/CIT/DIT by 19/01/2024.

2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority:-

a) His/her promotion is purely provisional;

b) He/she will be liable for reversion –

(i) if after a review of the vacancies, it is found that his/her promotion is in excess of the vacancies available;

Or

(ii) if found unfit for retention in the post of Stenographer Grade-I



- c) His/her appointment shall not confer any right to him/her for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DoPT as contained in O.M.No.28036/8/87-Estt. (D) dated 30.03.1988 and instruction issued by the Government from time to time.
- d) His/her promotion and seniority in the cadre of Stenographer Grade-I will be liable for revision at any point of time subject to seniority made in accordance with (i) O.A.No.598 of 2013 filed by Sri RSR Chandra Murthy and O.A.No.1325 of 2013 filed by Sri Manas Ranjan Behera filed before Hon'ble CAT (ii) Outcome of the OA No. 557 of 2014 filed by Sri G Maruthi Prasad and others before the Hon'ble CAT, Hyderabad Bench; (iii) Out come of any other cases pending before the Hon'ble CAT/other Courts, (iv) Any further orders which may be passed by the Hon'ble Supreme Court in DOP&T's O.M. in F.No.36012/11/2016-Estt.(Res-I) (Pt-II), Dated. 15.06.2018. (v) CBDT's letter in F.No.A-35015/26/2018-Ad. VI, Dated. 27.05.2019 & F.No.A -35015/26/2018-Ad.VI, Dated. 20.02.2020 and 12.02.2021, (vi) Outcome of Writ Petition(WPSR 57107/2022) pending before the Hon'ble High Court of Telangana (vii) O.A.No.788 of 2022 and OA No. 111 of 2023 pending before Hon'ble CAT, Hyderabad Bench (viii) Outcome of decision to be taken by a larger bench of five Hon'ble Supreme Court Judges, as mentioned at para 35 of judgement dated 14.12.2022 by Hon'ble Supreme Court in the case of Hariharan and others Vs. Harshvardhan Singh Rao { SLP (c) No. 16161 of 2018}.
- e) The promotions will be subject to the directions/clarifications issued by the Board/DOPT, in connection with the following OMs and any other OMs relating to the subject matter (i) DOPT's O.M. No.36012/2/96-Estt(Res.) dated 2/7/1997, (ii) DOPT's OM No.36028/17/2001/Estt(Res.) dated 24/7/2007 (iii) DOPT's O.M. No.36012/11/2016-Estt(Res.) dated 30/9/2016 (iv) DOPT's O.M. No.13013/2/2016-Ad.III dated 18/8/02017 (v) any further orders which may be passed by the Hon'ble Supreme Court, as per DOPT's O.M. No.36012/2/96-Estt(Res.)(Pt.II) dated 15/6/2018 (vi) CBDT letter in F.No.A-35015-26/2018-Ad.VI dt.27/05/2019, 20.02.2020, 12.02.2021 & 26.10.2021. (vii) DOPT OM No.20011/2/2019-Estt(D) dt.13.08.2021.
- f) The attention of the promoted official is invited to MHA's O.M. F. No.7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No.1/1/2008 & DOPT O.M no. 13/02/2017-Estt(Pay-I), dated. 27.07.2017 regarding Exercising of option for fixation of pay on promotion.
- g) His/her seniority in the cadre of Stenographer Grade-I will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.
- h) His/her promotion is subject to outcome of recasting of reservation rosters in the cadre of Stenographer Grade-I in accordance with i) DOP&T's O.M. No. 36012/45/2005-Estt (Res.) dated 10.08.2010 & ii) DOP&T's O.M. in F.No.36012/11/2016-Estt.(Res-I) (Pt-II), Dated. 15.06.2018.
3. If the pay of the official has already been upgraded under ACP / MACP scheme to the pay scale of Stenographer Grade-I then he/she will not be eligible for pay fixation consequent to this promotion.

4. The promotion order should be issued in the prescribed proforma, immediately.



5. **The promotion to the cadre of Stenographer Grade I [Erstwhile Stenographer Grade-II] in respect of the above mentioned officials is on in-situ basis and the place of posting of the above officials will be reviewed in due course.**
