

 - i) If, after a review of the vacancies, it is found that his / her promotions are in excess of the vacancies available; or
 - ii) If he / she are found unfit for retention in the post of Senior Private Secretary, (Group-'B'-Gazetted).
- c) His / Her promotion/appointment as Senior Private Secretary(Group-'B'-Gazetted) is subject to the outcome of Hon'ble CAT / Hon'ble Court's Order, if any.
- d) His / Her attention is invited to MHA's O.M. in F.No.7/1/80-Estt.P.I dated 26.09.1981 read with CCS (Revised) Pay Rules, 2016 regarding exercising of option for fixation of pay on regular promotion.
- e) The officer whose pay has been upgraded in the scale of Senior Private Secretary (Group-'B'-Gazetted) under ACP / MACP Scheme will not be eligible for pay fixation consequent on this promotion.


