

As per the Recruitment Rules, 2015 for “Tax Assistants” those who have been appointed on “Compassionate Ground, Sports Quota and etc. shall have to pass Computer “Data Entry Skill Test” by making not less than 8000 key depressions per hour.

Group ‘C’ employees, viz., Notice Server, Record Keepers, existing MTS/ newly recruited MTS and Senior Gestener Operators with a combined service of five years in Group ‘C’ and ‘D’ are eligible for promotion to the post of Tax Assistant. Such Employees have to pass Data Entry Skill Test by making not less than 5000 key depressions per hour.

In this connection, Computer Data Entry Skill Test 2023 is scheduled to be conducted on **12.05.2023** in two batches i.e., Morning batch from 11.00 am onwards and Afternoon batch from 03.00 pm onwards. The Schedule of Skill Test Examination is enclosed as Annexure.
