 - (ii) if found unfit for retention in the post of Tax Assistant.
3. His promotion as Tax Assistant is subject to outcome of any Cases pending before the Hon'ble CAT and Hon'ble Courts.
4. His promotion as Tax Assistant is subject to any clarification received from Board with regard to withdrawal of DR vacancies for the year 2017-18.
5. The official will not be eligible for pay fixation consequent to this promotion in case his/her pay has already been upgraded in the scale of Tax Assistant under ACP Scheme/MACP Scheme.
6. The attention of the promoted official is invited to the MHA's O.M. F.No. 7/1/80-Estt-P.1 dated 26.09.1981 and ministry of Finance, Department of Expenditure (implementation Cell) O.M in F.No. 01.01.2008 regarding exercising of option for fixation of pay on promotion. The promotion of the official is subject to any further orders which may be passed by the Hon'ble Supreme Court, as per DOPT's OM in F.No. 36012/11/2016-Estt[Res-I] [Pt-II] dated 15.06.2018.
7. The attention of the promoted official may be invited to F.R. 22(1)(a)(1) regarding exercising of option for fixation of pay on promotion.
