The CBDT vide its instructions dated F.No. A-35015/26/2018-Ad.VI, dated 26.10.2021 gave instructions for revision of seniority of Direct Recruits vis-à-vis Promotees in accordance with the principles laid down in the judgement of Hon'ble Supreme Court of India in Civil Appeal No. 8833-8835 of 2019 of K Meghachandra Singh & Ors Vs. Ningam Siro & Ors. Accordingly, a Task Force Committee was formed for revision of seniority lists.
