### MEMORANDUM

Sub: Request for Surrender of services of Mobile Connection /FTTH Broadband Connection / 3G Data Card availed under Project Tarang - Reg.

The Board has issued guidelines under Project Tarang-1 & 2 that all the Officers / Official of the Department shall compulsorily surrender the services of Mobile connection /FTTH Broadband Connection/3G Data Card at the time of Retirement or leaving the organization for any reason. However, on verification it is noticed that some of the officers/officials neither surrendered SIM Card/3G Data Card nor taken NOC from the Finance Section of this office for conversion of SIM in PREPAID, due to which this office is facing difficulties to allot SIM Card/Mobile Number to newly recruited officers and officials of the department.

In view of the above, all the retired officers/officials of the department who have neither surrendered the services of Mobile Connection /FTTH Broadband Connection /3G Data Card nor taken NOC for conversion of SIM in Prepaid at the time of retirement or leaving the department, are requested to surrender the services utilized under Project Tarang-1 & 2 or take NOC for conversion of SIM in Prepaid from finance section of this office on or before 03-06-2022 falling which their Mobile Number will be communicated to BSNL Authorities for deactivation.
