2. The following conditions should be mentioned in the promotion orders issued by the appointing authority:-

c) His promotion is purely provisional and

b) He will be liable for reversion –

(i) If, after a review of the vacancies, it is found that his promotion is in excess of the vacancies available;

or

(ii) If, found unfit for retention in the post of Staff Car Driver, Grade-II.

c) His promotion as Staff Car Driver, Grade – II, is subject to the outcome of the decisions in various applications/petitions pending, if any, before CAT/Court.

d) The official will not be eligible for pay fixation consequent to this promotion, in case, his pay has already been upgraded in the scale of Staff Car Driver, Grade – II, ACP Scheme/MACP Scheme.

e) The attention of the official promoted may be invited to F.R. 22(I)(a)(1) regarding exercising of option for fixation of their pay on promotion.

f) His seniority in the cadre of Staff Car Driver, Grade – II will be liable for revision at any point of time, if any bonafide mistake is found with reference to any records.

3. The promotion order should be issued in the prescribed proforma immediately.
4. Promotions to the cadre of Staff Car Drivers, Grade-II in respect of all the officials are on in-situ basis.
5. This issues with the approval of the Principal Chief Commissioner of Income Tax, AP & Telangana, Hyderabad.
