d) The attention of the promoted official is invited to MHA's O.M. F. No.7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No.1/1/2008 & DOPT O.M no. 13/02/2017-Estt(Pay-I), dated. 27.07.2017 regarding Exercising of option for fixation of pay on promotion.

e) His/her seniority in the cadre of Senior Tax Assistant will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.

3. If the pay of the official has already been upgraded under ACP / MACP scheme to the pay scale of Senior Tax Assistant then he/she will not be eligible for pay fixation consequent to this promotion.
