2. The Committee for compassionate appointments met on 28.02.2023 at 01:30 pm in the chamber of DCIT(H.Qrs.)(Admn.), O/o Pr.CCIT, AP&TS, Hyderabad. All the committee members were present in the meeting. The administration has informed the committee that the vacancies for filling up under compassionate appointment are 14, for the vacancy years 2019, 2020, and 2021.

3. The committee has decided to put one cut-off date i.e.31.12.2021, thus, applications received upto the cut-off date were to be examined. Accordingly, the applications received upto the cut-off date i.e. 79 applications were examined.


4. The Committee has perused the Scheme for Compassionate Appointment, 1998 issued by the DoP&T and the instructions on compassionate appointment, issued by DoP&T, vide its O.M.s in F.No. 14014/02/2012-Estt.(D), dated 16<sup>th</sup> January, 2013 and 07<sup>th</sup> October 2014 and subsequent clarifications issued from time to time including the latest DoP&T's OMs in F.N.43019/9/2019-Estt.(D), dated 23.08.2021 and Master Circular issued by the DoP&T vide O.M. in F.No.14014/1/2022-Estt.(D), dated 02.08.2022. Various judicial pronouncements including Hon'ble Supreme Court judgments were also studied. The Committee has perused Frequently Asked Questions (FAQs) on compassionate Appointment and answers of DoPT Establishment 'D' Division vide DOPT OM No. 14014/02/2012-Estt.(D), dated 30-05-2013.

5. The committee has decided to award points to each applicant under various heads as stipulated in CBDT's instruction in F.No.A-12012/03/2021-Ad.VII, dated 15.04.2021. Accordingly, considering the information on record, department official enquiry and facts of the case, each applicant is awarded points as per their entitlement. The committee has thoroughly examined each application before awarding such points. CBDT's instruction in F.No.A-12012/03/2021-Ad.VII, dated 15.04.2021 is as under:




6. The committee did not consider the following applications for the reasons mentioned below:

(ii) Kum S. Divya, D/o Late Sri S. Yadaiah, TA, O/o Pr. CCIT, A.P. & TS, Hyderabad: The applicant's mother is a Government Teacher at MPMP School, Kurnool. She is getting a gross salary of Rs. 57,630/- and a family pension of Rs. 9000/- p.m. (Total is Rs. 66,630/-). The committee did not consider this candidate for awarding marks because the family cannot be treated as financial distress.


(iii) Shri B. Gangadhar, S/o Late Shri B. Ram Prasad, OS, O/o Addl.CIT, Range-8, Hyderabad: There is a legal heir dispute in this case between the first wife and second wife of the deceased official. Both have filed cases claiming their right as legal heir in CAT, the decision of which is pending as on date. Even the application has not been received through proper channel from the office where the deceased official last worked. The applications may be considered in future once the dispute about legal heir is decided.

(iv) Kumari Spoorthi Navya, D/o Late K. Narsing Rao, Sr.TA, O/o Addl.CIT, Range-6, Hyderabad: The applicant's D.O.B. is 06.07.2007. Thus, still she is minor and has not attained the age of 18. The administration vide letter dated 22.11.2019 has communicated to the applicant's mother that, they can apply for compassionate appointment for her daughter after she attains the minimum age required i.e. 18 years. In view of the above, the committee did not consider her application.


(v) Sri G. Balaji Prasad, S/o Late G. Penchalaiah, ITI, O/o ITO, Ward-1, Nandyal, D.O.B.15.08.1946 and Date of Missing (01.04.2006): The applicant's previous filed application dated 15.05.2014 is rejected vide CCIT(CCA), Hyderabad's MEMORANDUM, dated 30.09.2014, for not fulfilling one of the eligibility criteria as under: *The missing Govt. servant must had, at least, Two years of service for superannuation on the date of missing. Again, I am directed to communicate that no further correspondence/requests, for compassionate appointment, from the applicant or from any other family members in future.* In view of the above, his application is not considered by the committee.


(vi) Kumari Peddinti Sai Lakshmi, D/o Late Peddinti Appa Rao, NS, O/o ITO, Ward-1, Vizianagaram: The applicant has not submitted the prescribed form for compassionate appointment and relevant documents. Accordingly, letters dated 11.08.2021 & 02.03.2022 were sent to the applicant to submit the relevant document along with prescribed proforma. In response, no reply received from the applicant. In view of the above, her application is not considered by the committee.

(vii) Smt. Rajolu Nagamani, D/o Sirasapalli Srinu, Mohd. Shafi, S/o Late Sri Mohd. Saleem, N.S., O/o Addl. CIT, Range-5, Hyderabad: The applicant has not passed SSC/Matriculation, the minimum qualification prescribed for appointment to the post of MTS. The Committee after carefully going through the case is of the considered opinion that there are no exceptional circumstances to invite the relaxation of guidelines which are mentioned under Para 6 B (b) of "Scheme for Compassionate appointment". 
Estt.(D) dated 11.12.2009), which speaks about the relaxation from the minimum qualification required for appointment. In view of the above, his application is not considered by the committee.

As per the instructions of CBDT's letter in F.No.A-12012/40/2022-Ad.VII, dated 23.09.2022, the committee has followed the DoP&T's Master Circular on Scheme of Compassionate Appointment vide OM in F.No.14014/1/2022-Estt.(D), dated 02.08.2022. Accordingly, the committee has decided to communicate each applicant of their total earned merit points i.e. merit points earned against each parameter alongwith total merit points earned.
