(i) if after a review of the vacancies, it is found that their promotions are in excess of the vacancies available;

Or

(ii) if found unfit for retention in the post of Senior Tax Assistant

c) their promotion as Senior Tax Assistant is subject to outcome of the decisions in various applications / petitions pending, if any, before CAT/Court, including writ petition in WP MP No. 40310 / 2010 in WP No. 31699/2010 pending before the Hon'ble High Court of Andhra Pradesh.



    - (ii) Or if, found unfit for retention in the post of Tax Assistant.
3. Their promotion as Tax Assistant is subject to the outcome of the decisions in various applications/petitions pending, if any, before CAT/Court.
4. The officials will not be eligible for pay fixation consequent to their promotion in case their pay has already been upgraded in the scale of Tax Assistant under ACP/MACP Scheme.
5. The attention of the officials promoted may be invited to F.R. 22(I)(a)(1) regarding exercising of option for fixation of their pay on promotion.
6. Their seniority in the cadre of Tax Assistant will be liable for revision at any point of time if any bona-fide mistake is found with reference to any records.
7. The promotion order should be issued in the prescribed proforma, immediately.
8. This issues with approval of the Chief Commissioner of Incometa(CCA), Hyderabad.
