**support the application. To access the above said live classes the user has to install**  
**and login through Mobile Phone/Systems to attend the online Lectures. The Link &**  
**credentials for joining lecture and schedule for the courses will be shared through email or**  
**SMS or Whatsapp by the MSTU, Hyderabad. All the officials nominated for the course**  
**are directed that if the sessions are planned in either half of the day, regular office**  
**work may be attended in other half of the day. The officials whose EmailIDs/Mobile**
