2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority:-

a) His/her promotion is purely provisional and,

b) He/she will be liable for reversion -

(i) if, after a review of the vacancies, it is found that his/her promotion is in excess of the vacancies available;

or

(ii) if, found unfit for retention in the post of Senior Tax Assistant.

c) His/her appointment shall not confer any right to them for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DOP&T as contained in O.M. no. 28036/8/87-Estt. (D) dated 30.03.1988 and instruction issued by Government from time to time.

d) His/her promotion as Senior Tax Assistant is subject to the outcome of the decisions in various applications/petitions pending, if any, before Hon'ble CAT/Hon'ble Courts.

e) Their promotion as Sr. Tax Assistant are subject to outcome of decision by the Hon'ble CAT in O.A no. 020/00557/2014 dated 02.01.2015

f) The official will not be eligible for pay fixation consequent to this promotion in case his/her pay has already been upgraded in the scale of Senior Tax Assistant under ACP Scheme/MACP Scheme.

g) The attention of the official promoted may be invited to F.R. 22(I)(a)(1) regarding exercising of option for fixation of his pay on promotion.

h) The promotions are liable for reversion, if found ineligible on account of seniority consequent to implementation of N.R.Parmar judgement.

i) The above promotions to the cadre of Sr. Tax Assistants are on in-situ basis.

j) His/Her seniority in the cadre of **Senior Tax Assistant** will be liable for revision at any point of time if any bonafide mistake is found with reference to any records

3. The promotion order should be issued in the prescribed proforma, immediately.

4. **Postings of the above mentioned official will be reviewed till further order or during the Annual General Transfers, 2016, whichever is earlier.**

5. This issues with the approval of the Pr. CCIT, AP & Telangana.
