(ii) if found unfit for retention in the post of Tax Assistant.


3. His/Her promotion as Tax Assistant is subject to outcome of any Cases pending before the Hon'ble CAT and Hon'ble Courts.

5. The official will not be eligible for pay fixation consequent to this promotion in case his/her pay has already been upgraded in the scale of Tax Assistant under ACP Scheme/MACP Scheme.
