**CORRIGENDUM**

In the allotment order for the promotion to the cadre of Tax Assistants vide reference cited above, point No.(a) of Para 2 of the order was inadvertently omitted. Hence, the same is incorporated as under:

- a) **“Their promotion is purely provisional;”**
2. Similarly in the 4<sup>th</sup> line of para 6 of the order, it was incorrectly mentioned as *“Any further orders which may be passed by the Hon’ble Supreme Court, as per DOPT’s OM in F.No. 3602/11/2016-Estt[Res-I] [Pt-II] dated 15.06.2018”*. Hence, the same may be read as under:
