MEMORANDUM

Sub: Establishment – IT Department, AP & TS – Special Course for Assessing Officers from 15.10.2018 to 16.10.2018 at DTRTI, Bangalore – Nomination of officers - Regarding.

The following Officers as per Annexure are hereby nominated for the Special Course for Assessing Officers from 15.10.2018 to 16.10.2018 at DTRTI, Bangalore

2. Training for better delivery is a huge challenge in contemporary times. For the department of Income Tax, its sole and most significant asset is manpower and accordingly, equipping government personnel with necessary skills is utmost importance. Thus, the Heads of Office concerned are directed to relieve the officials so as to enable them to attend the training.
3. In connection with training, DTRTI, Bangalore requested to inform the nominated officers to bring specific cases involving any of the issues, which are currently handled by the officers on the following topics.
 1. Taxation of Bogus Capital Gains involving Penny Stocks.
 2. Taxation of Derivative and Commodity Market Transactions.
 3. Principles of taxation involving Accommodation entries, Bogus bills, etc.
 4. Taxation of Co-operative Societies.
4. The Principal Chief Commissioner of Income Tax (CCA) desires that the officers sponsored for training should not apply for leave during this period. If any of the officer has already applied for leave, he/she should suitably revise the period of leave so that he / she can attend the training. Attending the training is obligatory and absence there from will be treated as dereliction of duty.
5. Even if any of the officer is under orders of transfer from the present office, or any particular officer has not reported for duty at the place of posting, he/she should invariably attend the training course.
