3. (i) **This order will come into effect from 16-04-2012**
- (ii) All the Head of offices are required to relieve the officials under orders of transfer positively by **23-04-2012**
- (iii) In case any official is being proposed to be retained beyond **23-04-2012**, the Head of office shall take prior written approval from the CCIT(CCA), Hyderabad and for this purpose, the proposal should be sent well in advance. No official shall be retained beyond **23-04-2012** without prior approval.
- (iv) The officials under orders of transfer shall not be granted Earned Leave by the Competent Authority under whom they are presently working. Leave applications, if any, may be forwarded to the new place of posting for necessary action.
- (v) The Head of Offices are directed to send separate reports on relieving of as well as joining of officials from/to their offices latest by **26-04-2012** for updating the data in records.
