2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority:

a) their promotions are purely provisional

b) they will be liable for reversion,

i) If on a review of the vacancies, it is found that their promotions are in excess of the vacancies available;

ii) If found unfit for retention in the post of Administrative Officer, Grade-III (Group 'B' Gazetted).

iii) their promotion/appointment as Administrative Officer (Grade-III) (Group 'B' Gazetted) is subject to the outcome of Hon'ble CAT / Hon'ble Court's Order, if any.

iv) their attention is invited to MHA's O.M. in F.No.7/1/80-Estt.P.I dated 26.09.1981 read with CCS (Revised) Pay Rules, 2008 regarding exercising of option for fixation of pay on regular promotion.


v) their seniority in the cadre of Administrative Officer (Grade-III) (Group 'B' Gazetted) will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.

vi) The officers will not be eligible for pay fixation consequent on this promotion, if their pay has been upgraded in the scale of Administrative Officer (Grade-III) (Group 'B' Gazetted) under ACP/MACP Scheme.

vii) On promotion, the officials are appointed against the sanctioned posts i.e AO, Grade-III in the Principal CIT/CIT/CIT(A) Offices.

3. The promotion order should be issued in the prescribed proforma immediately.
