- d) His / her attention is invited to MHA's O.M. in F.No.7/1/80-Estt.P.I dated 26.09.1981 read with CCS (Revised) Pay Rules, 2016 regarding exercising of option for fixation of pay on regular promotion.
- e) His / her seniority in the cadre of Administrative Officer (Grade-III) (Group 'B' Gazetted) will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.
