Both Windows & IOS of desktop/ laptops/tabs will support the application. To access the above said live classes the user has to install and login through Mobile Phone/Systems to attend the online Lectures. The Link & credentials for joining lecture and schedule for the courses will be shared through email or SMS or Whatsapp by the MSTU, Hyderabad.* The officials whose EmailIDs/MobileNos are not displayed in the annexure shall contact the officials of MSTU, Hyderabad; Sri.
