Ref: DO letter, dated 28.02.2022, received from the Pr.DGIT(HRD), CBDT, New Delhi.



Sub:- Launch of India Hub on the Knowledge Sharing Platform for Tax Administrators on the
FTA Capacity Building Network- reg.

Knowledge Sharing Platform for Tax Administrators (KSPTA) is a global online resource managed by the Forum on Tax Administration (FTA) for sharing knowledge and expertise in tax administrators which supports tax capacity building efforts in tax administrations by improving access to tax knowledge and expertise; and, increasing collaboration among tax administrators and organizations.

2. The KSPTA is a useful repository of tax related information and would be highly beneficial for our officers. It has online e-learning modules and recorded webinars on topics of relevance available free of cost for tax administrators of member countries. This will enhance capacities of officers of the Department in important areas of tax administration such as BEPS, International tax, Collection Enforcement, Compliance Verification and Audit, Dispute Resolution, Human Resource Management, Information Technology and Legal and Policy Framework available through self-learning mode. Access to the platform is limited to government officials working in tax administration, policy and crime, as well as representatives of international and regional tax organizations.

3. The Directorate of Human Resource Management had initiated discussion with FTA Capacity Building Network for enrolment of officers of the Income tax Department on the KSPTA. The FTA has now created an India Hub for the KSPTA and this Directorate has been nominated as hub administrator for India. It is felt that the huge repository of good quality tax related learning resources available on this platform would be highly beneficial for officers of the Income Tax Department.

4. In view of the above, you are requested to please ensure that officers of the rank of ACIT and above posted in your charge register themselves on the KSPTA portal through the link <https://ksp-ta.org>. They are required to mandatorily register using their email id on 'incometax.gov.in' domain as this domain has been whitelisted on the portal.
