MEMORANDUM

Sub. : **Establishment - I.T. Department, Hyderabad - Reversion to the cadre of
Income Tax Inspector from the cadre of Income Tax Officer - Regarding.**

Consequent to the review of seniority in various cadres of Income Tax department, Andhra Pradesh and Telangana, including that of Income Tax Inspector, as per Hon'ble Supreme Court's judgement in the case of Union of India Vs. N.R.Parmar in CA No.7514-7515 and as per order of the Hon'ble CAT, Hyderabad Bench in OA No.598 of 2013 filed by Sri R.S.R.Murthy and OA No.1325 of 2013 filed by Sri Manas Behera & others, review DPCs for promotion to the cadre of ITO which were held for earlier years upto vacancy year 2014-15, were convened on 01.12.2015.

2. As per the findings of the review DPCs convened on 01.12.2015, the names of the following Income Tax Officers who were earlier promoted to the cadre of Income Tax Officer for the vacancy year mentioned against their names have not figured in the select panels recommended by the DPC.
