NOTIFICATION

Vide Board's Order No.220 of 2017 in F.No.A-32012/3/2017-Ad.VI dt.29.12.2017, the following Dy. Commissioners of Income Tax are promoted as Joint Commissioners of Income Tax on ad-hoc basis in Level-12 in the pay matrix Rs.78800-209200 against panel year 2017-18 w.e.f. 01.01.2018 or assumption of charge of the post, whichever is later, for a period not exceeding one year on in situ basis.
