2. The concerned CCsIT/DGIT/PDIT/PCsIT/CsIT/DIT shall make necessary postings in respect of all officials who are posted in their charge without changing the station, under intimation to this office.
3. All the Heads of Offices are required to relieve the officials under orders of transfer positively by **21/07/2023**.
4. The officials under orders of transfer shall not be granted Earned Leave by the Competent Authority under whom they are presently working. Leave applications, if any, may be forwarded to the new place of posting for necessary action.
5. In case any official is being proposed to be retained beyond the above mentioned date, the Head of office shall take prior written approval from the Pr.CCIT, AP & Telangana, Hyderabad.
6. The Heads of Offices are directed to send separate compliance report on relieving and joining of officials from/to their offices latest by **28/07/2023**.
7. All representation received are considered and stands disposed off.
8. As per clause IV of Transfer Policy for Group 'B' (Non Gazetted) & Group 'C' Officials (Other than Staff Car Drivers) of Income Tax department, AP & Telangana Region, unless the transfer order is cancelled either suo-moto or on representation, before the due date of relieving the transferee shall be considered as deemed relieved on the due date given in the transfer order. It is clarified that representation made against the transfer shall not confer any right whatsoever on the official to continue at the previous post in defiance of the transfer order. In view of this, if any of the Official is not relieved by due date, he/she shall be deemed relieved by next working day.
