Sub:- Validation of landline/mobile connections under PROJECT TARANG—  
regarding.

This is to intimate that BSNL made a requisition to submit the updated list of land-line connections/residential lines/FTTH numbers/mobile numbers provided to the Offices/Officers/officials, for the purpose of updating/validating the "PROJECT TARANG" scheme. As the details of fresh connections obtained by various offices and the details of surrendered connections, if any, are not available with this office, it is necessitated to have a centralised data-base at this end, for transmitting the same to the BSNL as sought for.

2. For this purpose, it is requested to kindly provide all the Landline connection numbers functioning at present in all the offices under your administrative control, with a specific remark as to whether it has been covered under Project Tarang hitherto, and if not, a request can be made for inclusion under Project Tarang afresh. Similar exercise may be carried out in respect of all the residential lines/FTTH provided to the Officers. The information may please be provided in the enclosed proforma-A.

3. It is also requested to obtain and submit the details of all the mobile numbers allotted by the department to the officials working in AP&TS. The information may please be provided in the enclosed proforma-B. In case, if some connections are de-activated for any reason, please specify separately so that a request can be made for the exclusion of such numbers.

4. I have been directed to request that the information sought for as above should be submitted by 30-01-2023, so as to enable this office to submit the same by 31-01-2023 to the BSNL. This may please be treated as URGENT.
