5. It may also be highlighted that TIWB assignments do not involve relocation between duty stations to country assigned. The willing officers are requested to apply for the above programme as per application procedure of the Roster Expert as illustrated in the Vacancy Circular of the UNDP by **17.04.2023 (Midnight New York, USA)** and **inform the Cadre Controlling Authority as per DoPT instructions.**
