Sub: Posting at CPC-ITR Bangalore and Demand Management Centre, Mysore under the CPC Staffing Scheme - reg.

Kindly refer to the Staffing Scheme for the Centralized Processing Centre (CPC) Staffing Scheme 2011 circulated by HRD with the approval of the Competent Authority.

2. In view to strengthen the current manpower requirements, it is informed that applications for posting at CPC-ITR Bangalore and Demand Management Centre, Mysore are being called for from the willing officers/ officials of Group B and C.

3. The officers/ officials volunteering for postings in CPC-ITR Bangalore and Demand Management Centre, Mysore need to be qualified as per the scheme to suit the requirements of the present assignment. The tenure of the posting will be for 3 years extendable to 5 years.

4. It is also informed that as per the scheme, for those Group B and C officers/ officials of Pr.CCIT(CCA) regions who are desirous to serve in the CPC-ITR Bangalore and Demand Management Centre, Mysore (selected through a process already laid down in the scheme) the officer/ official would move along with his/ her post on temporary transfer along with temporary diversion of post from their respective cadre controlling authority. All officers/ officials posted at CPCs/DMCs would be eligible to draw their pay and allowances from the respective CPC/DMC itself. The post will then revert back to the respective cadre controlling authority automatically on completion of tenure/ premature reversal, for any reason whatsoever.

5. The respective seniority lists at each cadre/ home regions for Group B and Group C employees would remain unaltered under this scheme.

6. All applications of willing Group B and Group C employees shall be routed through the Pr.CCIT(CCA) of the home region.
