    - (ii) if found unfit for retention in the post of Stenographer Grade-II
  - c) His/her appointment shall not confer any right to him/her for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DoPT as contained in O.M.No.28036/8/87-Estt. (D) dated 30.03.1988 and instruction issued by the Government from time to time.
  - d) His/her promotion and seniority in the cadre of Stenographer Grade-II will be liable for revision at any point of time subject to seniority made in accordance with (i) O.A.No.598 of 2013 filed by Sri RSR Chandra Murthy and O.A.No.1325 of 2013 filed by Sri Manas Ranjan Behera filed before Hon'ble CAT (ii) Outcome of the OA No. 557 of 2014 filed by Sri G Maruthi Prasad and others before the Hon'ble CAT, Hyderabad Bench; (iii) Out come of any other cases pending before the Hon'ble CAT/other Courts, (iv) Any further orders which may be passed by the Hon'ble Supreme Court in DOP&T's O.M. in F.No.36012/11/2016-Estt.(Res-I) (Pt-II), Dated. 15.06.2018.(v) CBDT's letter in F.No.A-35015/26/2018-Ad. VI, dated 27.05.2019.
  - e) The promotions will be subject to the directions/clarifications issued by the Board/DOPT, in connection with the following OMs and any other OMs relating to the subject matter (i) DOPT's O.M. No.36012/2/96-Estt(Res.) dated 2/7/1997, (ii) DOPT's OM No.36028/17/2001/Estt(Res.) dated 24/7/2007 (iii) DOPT's O.M. No.36012/11/2016-Estt(Res.) dated 30/9/2016 (iv) DOPT's O.M. No.13013/2/2016-Ad.III dated 18/8/02017 (v) any further orders which may be passed by the Hon'ble Supreme Court, as per DOPT's O.M. No.36012/2/96-Estt(Res.)(Pt.II) dated 15/6/2018 (vi) CBDT letter in F.No.A-35015-26/2018-Ad.VI dt.27/05/2019, 20.02.2020, 12.02.2021 & 26.10.2021. (vii) DOPT OM No.20011/2/2019-Estt(D) dt.13.08.2021.
  - f) His/her seniority in the cadre of Stenographer Grade-II will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.
  - g) His/her promotion is subject to outcome of recasting of reservation rosters in the cadre of Stenographer Grade-II in accordance with i) DOP&T's O.M. No. 36012/45/2005-Estt (Res.) dated 10.08.2010 & ii) DOP&T's O.M. in F.No.36012/11/2016-Estt.(Res-I) (Pt-II), Dated. 15.06.2018.
3. If the pay of the official has already been upgraded under ACP / MACP scheme to the pay scale of Stenographer Grade-II then he/she will not be eligible for pay fixation consequent to this promotion.
