    - if after a review of the vacancies, it is found that his/her promotion is in excess of the vacancies available;



  - His/her appointment shall not confer any right to him/her for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DoPT as contained in O.M.No.28036/8/87-Estt. (D) dated 30.03.1988 and instruction issued by the Government from time to time.
  - His/her promotion and seniority in the cadre of Stenographer Grade-I will be liable for revision at any point of time subject to seniority made in accordance with (i) O.A.No.598 of 2013 filed by Sri RSR Chandra Murthy and O.A.No.1325 of 2013 filed by Sri Manas Ranjan Behera filed before Hon'ble CAT (ii) Outcome of the OA No. 557 of 2014 filed by Sri G Maruthi Prasad and others before the Hon'ble CAT, Hyderabad Bench; (iii) Out

  - h) The promotions are liable for reversion, if found ineligible on account of seniority consequent to implementation of N.R. Parmar Judgement.
3. If the pay of the official has already been upgraded under ACP / MACP scheme to the pay scale of Stenographer Grade-I then he/she will not be eligible for pay fixation consequent to this promotion.
  4. **Promotion to the cadre of Stenographer Grade-I in respect of all the above mentioned officials are on *in-situ* basis. These Stenographers Grade-I shall continue to discharge the same functions as Stenographer Grade-II in their respective offices till further orders.**
