**Rule Provision:-** In this connection, attention is invited to GID (2) below Rule 64 of C.C.S (Pension) Rules wherein it is inter alia stated that "In a case where no major recoveries are due but 10% of the gratuity or Rs. 1000/- has been withheld because there might be unassessed Govt. dues or because the gratuity has been provisionally paid or became LPC has not been received, the withheld amount shall automatically become payable on the expiry of the six months after retirement."

**Observation:-** On scrutiny of the gratuity register that relating to unreleased withheld gratuity, it is observed that in many cases withheld gratuity have not been released even after six months after retirement. A list of unreleased withheld gratuity is mentioned below:-
