ii) If found unfit for retention in the post of Staff Car Driver Special Grade.

c) His promotion as Staff Car Driver, Special Grade is subject to the outcome of any cases pending before the Hon'ble CAT and Hon'ble Courts.

d) The attention of the promoted official is invited to the MHA's O.M. F.No. 7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No. 01/01/2008 regarding exercising of option for fixation of pay on promotion. Any further orders


