Kind reference is invited to the DG, CEIB's D.O. letter No. CEIB/CS-5 (9) Trg. Misc. 2014 (Pt.) dated 20th January, 2015.

In this regard, as already intimated vide the aforementioned letter, a capsule course on legal matters is going to be organized by the Bureau, to help the Revenue Officers to equip themselves with the various legal and procedural aspects.

The Course shall be conducted by National Law University, New Delhi which is scheduled to be held during 20-25 April, 2015. The cost of Course for each participant would be approximately Rs. 25,000/- and is to be borne by the concerned organization. The NLU would also be providing accommodation, which would be separately chargeable but will be within entitlement of officers.

As this would be start of the Course, maximum participation would be desired for further coordination.
