**Sub:** Restricted Holiday to be observed in Central Government Offices located in Andhra Pradesh & Telangana on account of 'Janmashtami' on 03.09.2018 - reg.

**Ref:** This office Circular in F. No. CGEWCC/Holiday/2018 dated 17.08.2018.

This is for the kind information of all the Central Government Offices located in Andhra Pradesh & Telangana States that vide reference cited above, the Restricted Holiday declared on 15.01.2018 (Monday) on account of 'Kanuma Festival' was converted as a Closed Holiday. Since the total number of closed holidays have to be kept at 17 only, the holiday declared on account of 'Janmashtami' on 03.09.2018 was withdrawn.

In this regard, several requests have been received that since 15.01.2018 was converted as a Closed Holiday, it may be considered to declare 'Janmashtami' as a 'Restricted Holiday' in view of the fact that both the State Governments of Andhra Pradesh & Telangana have declared Janmashtami as a closed holiday. **After considering the matter, it is decided that all the Central Government Offices in Andhra Pradesh & Telangana will observe 'Janmashtami' on 03.09.2018 as Restricted Holiday.**
