The date of joining of the Officers shall be intimated to this office by respective CCIT/DGIT/PCIT/PDIT/CIT/DIT by **08/01/2024**

- Promotions to the cadre of Administrative Officer, Grade-II is on *in-situ* basis. These Officers shall continue to discharge the same functions as Administrative Officer, Grade-III in their respective Offices till further orders. The postings of Administrative Officers (Grade-II) will be reviewed in the AGT-2024.
- The following conditions should be mentioned in the promotion order to be issued by the appointing authority mentioned at column no.3 above:
 - His promotion is purely provisional.
 - He will be liable for reversion.
 - If on a review of the vacancies, it is found that his promotion is in excess of the vacancies available.
 - If found unfit for retention in the post of Administrative Officer, Grade-II (Group 'B' Gazetted).
 - His promotion/appointment as Administrative Officer (Grade-II) (Group 'B' Gazetted) is subject to the outcome of Hon'ble CAT / Hon'ble Court's Order, if any.



- d) His attention is invited to MHA's O.M. in F.No.7/1/80-Estt.P.I dated 26.09.1981 read with CCS (Revised) Pay Rules, 2016 regarding exercising of option for fixation of pay on regular promotion.
- e) His seniority in the cadre of Administrative Officer (Grade-II) (Group 'B' Gazetted) will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.
- f) The officer will not be eligible for pay fixation consequent on this promotion, if his pay has already been upgraded in the scale of Administrative Officer (Grade-II) (Group 'B' Gazetted) under ACP/MACP Scheme.
