2. The following conditions should be mentioned in the promotion order issued by the appointing authority:-

a) Their promotion is purely provisional;

b) They will be liable for reversion –

(i) if after a review of the vacancies, it is found that their promotions are in excess of the vacancies available;

Or

(ii) if found unfit for retention in the post of Office Superintendent

c) Their promotion and seniority in the cadre of Office Superintendent will be liable for revision at any point of time subject to seniority made in accordance (i) Outcome of the OA No. 557 of 2014 filed by Sri G Maruthi Prasad and others before the Hon'ble CAT, Hyderabad Bench; (ii) Outcome of any other cases pending before the Hon'ble CAT/other Courts.

d) The attention of the promoted officials is invited to MHA's O.M. F. No. 7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No.1/1/2008 regarding Exercising of option for fixation of pay on promotion.

e) Their seniority in the cadre of Office Superintendent will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.

f) Their promotion is subject to outcome of recasting of reservation rosters in the cadre of Office Superintendent in accordance with DOP&T's O.M. No. 36012/45/2005-Estt (Res.) dated 10.08.2010.

g) This promotion order is subject to the result and outcome of recommendations of N.R.Parmar Committee constituted in this Region.

3. If the pay of the officials has already been upgraded under ACP/MACP scheme, then they will not be eligible for pay fixation consequent to this promotion.
4. Promotions to the cadre of Office Superintendent in respect of all the officials are on in-situ basis.
5. **Postings of the above mentioned officials will be reviewed during Annual General Transfers, 2016.**
6. This issues with the approval of the Principal Chief Commissioner of Income Tax, AP & Telangana, Hyderabad.
