NOTIFICATION

Vide Board's Order No.221 of 2018 in F.No.A-32012/3/2018-Ad.VI, dt.31.12.2018, the following Dy. Commissioners of Income Tax are promoted as Joint Commissioners of Income Tax on ad-hoc basis in Level-12 in the pay matrix Rs.78800-209200, w.e.f. 01.01.2019 or assumption of charge of the post, whichever is later, for a period not exceeding one year on in situ basis.

2. As per the Board's order, the appointments are intended to be on ad-hoc nature subject to the following conditions:

- (i) Such appointments shall not confer any right to the officers for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DOP&T as contained in O M No. 28036/8/87-Estt(D) dated 30.03.1988 and instructions issued by Government from time to time.
- (ii) These appointments will not confer any right or equity in favour of the appointees.

In compliance to Board's order mentioned above, the under mentioned posts are hereby created to enable the promoted officers to assume the charge in the cadre of Joint Commissioner of income tax and Level 12 in the pay matrix on Ad-hoc and in situ basis. These officers will continue to discharge the same functions and duties as they were discharging before their promotions, to the newly created posts, until further orders.


3. The above mentioned posts are deemed to be abolished with effect from the date on which the incumbent officers relinquishes the charge.
