The Direct Taxes Regional Training Institute, Bengaluru has conducted a Refresher Course Phase-1 from 05.07.2021 to 09.07.2021 for the ITIs of Karnataka & Goa and Andhra Pradesh & Telangana regions. This is a mandatory course for the ITIs who have completed 4 years of service as ITI in the Department. Now the DTRTI, Bengaluru is conducting the Phase -II of the said course from 29.11.2021 to 03.12.2021 on online mode.

2. In view of the present restrictions to contain the spread of COVID-19 and under the directions of NADT, Nagpur, the course is planned to be conducted through online mode. The schedule will be shared with the participants in due course.

3. As per the National Training Syllabus, the Refresher Course for Inspectors is for duration of 10 training days. However due to pandemic, the course has been split into two phases. The first phase was completed from 05.07.2021 to 09.07.2021. The second phase of training is scheduled from 29.11.2021 to 03.12.2021.

4. The main objective of course is to update the participants with the latest substantive & procedural law of Income Tax. Inputs would also be provided on land-mark judgments in the last 4 years and ITI's roles in new set-up of the department. The participants will also be benefitted from the case studies on various topics, which will be covered during the training program.

5. Vide letter cited in Ref.(2), in total 86 Inspectors were nominated and out of which 74 Inspectors attended the course. Hence, it is requested that the Inspectors who have undergone the course in Phase I may be nominated for the course.
