2. The responsibilities and functions of CPIOs and Appellate Authorities in respect of this order are by designation, and shall automatically be conferred on the successor officer in case of change of incumbency.

3. The new structure would be with effect from the date of issue of this order. The newly designated CPIOs and Appellate Authorities would deal with RTI applications received with effect from the date of this order. Accordingly, even after the new structure is made functional, the RTI applications received prior to the date of issue of this order would continue to be dealt with by the earlier designated CPIOs/Appellate Authorities and they would cease to function as CPIOs/Appellate Authorities only after all the arrear RTI applications/appeals are finally disposed off.
