



Note on the principles adopted in preparing the seniority list of LDC cadre

1. New RY is based on the requisition letter sent to the SSC as mentioned in Annexure-A
2. For the same recruitment year and year of exam, SSC rank is followed
3. Seniority of the officials joined under other modes of recruitment viz., compassionate grounds, Sports quota, Surplus Cell, interchange/interdepartment is fixed on the basis of the instructions/guidelines issued by the DOPT/CBDT from time to time.
4. Wherever date of joining/year of joining is not available, existing seniority as per the Establishment list is followed
5. Date of requisition is available for 1990 & 1992 year of exams. Hence, candidates recruited through 1991 year of exam are put under the RY-1992-93.
6. Inter se seniority of the officials joined on interdepartmental transfers is fixed as per the existing seniority list.
