- His/her promotion as Notice Server is subject to outcome of any Cases pending before the Hon'ble CAT and Hon'ble Courts.
- His/her promotion as Notice Server is subject to outcome of decision by the Hon'ble CAT in O.A no. 020/00557/2014 dated 02.01.2015.
- The attention of the promoted official is invited to MHA's O.M. F. No.7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of

Expenditure (Implementation Cell) G.M. in F.No. 1/1/2008 regarding exercising of option for fixation of pay on promotion.

- e) His/her seniority in the cadre of Notice Server will be liable for revision at any point of time, if any bonafide mistake is found with reference to any records.
 - f) His/her promotion is subject to outcome of recasting of reservation rosters in the cadre of Notice Server in accordance with DOP&T's O.M.No. 36012/45/2005-Estt(Res.) dated 10.08.2010.
 - g) The official will not be eligible for pay fixation consequent to this promotion in case his pay has already been upgraded in the scale of Notice Server under MACP Scheme.
3. The promotion order should be issued in the prescribed proforma immediately.
 4. In respect of the following officials, the promotion to the cadre of Notice Server is deferred due to non-receipt of APARs as mentioned against his/her name.

A review DPC will be conducted on receipt of the APARs of the officials, and the seniority of the official will be restored.
