(v) CBDT's letter in F.No.A-35015/26/2018-Ad. VI, Dated. 27.05.2019 & F.No.A -35015/26/2018-Ad.VI, Dated. 20.02.2020 and 12.02.2021.

d) The attention of the promoted official is invited to MHA's O.M. F. No.7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No.1/1/2008 & DOPT O.M no. 13/02/2017-Estt(Pay-I), dated. 27.07.2017 regarding Exercising of option for fixation of pay on promotion.

e) His/her seniority in the cadre of Office Superintendent will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.

f) His/her promotion is subject to outcome of recasting of reservation rosters in the cadre of Office Superintendent in accordance with i) DOP&T's O.M. No. 36012/45/2005-Estt (Res.) dated 10.08.2010 & ii) DOP&T's O.M. in F.No.36012/11/2016-Estt.(Res-I) (Pt-II), Dated. 15.06.2018.


g) His/Her promotion will be subject to the directions / clarifications issued by the Board / DOPT in connection with the following OMs and any other OMs relating to the subject matter
