Other Terms and Conditions of the Competition:

- (i) The Poster/Banner should promote the theme of 75 Years of Independence.
- (ii) The participants in the competition may use A3 or A4 sheet for poster/Banner. Write up text (slogan) of the Poster should be submitted in readable font of Hindi/English and it should be written on the poster itself. It should be ensured that the uploaded poster is clearly visible.
- (iii) The Poster/ Banner should be **JPG / JPEG** format and may be sent as an attachment to the email alongwith participation form and should not exceed the permissible limit allowed in the email.
- (iv) All entries must be consolidated at the end of Pr.CCIT (CCA) and it may be ensured that **each participant submits only one entry**. In case it is found that any participant has submitted more than one entry, all entries will be considered invalid for the said participant.
- (v) The entry should be original. Copied entries will not be considered under the competition.
- (vi) Please note that the work must be original and should not violate any provision of the Indian Copyright Act,1957. Anyone found infringing on others' copyright would be disqualified from the competition.
- (vii) Directorate of Income Tax (O&MS) does not bear any responsibility for copyright violations or infringements of intellectual property carried out by the participants.
- (viii) The name of the participant, email etc should not be mentioned anywhere in the body and if done, will lead to disqualification.
- (ix) Participants are required to fill and share the participation form which includes details such as name, relationship with the officer/official of the Department, Age etc.
- (x) Entries will be judged on the Theme Originality (demonstrates a unique incorporation of Independence & theme), overall neatness and artistic quality.
