Quotations are invited from the interested Parties/Travel agencies for supply of one mid-size air conditioned vehicle capable of carrying 7 or more persons on monthly hire basis for the office use (operational purpose) of the O/o the Addl. Commissioner of Income tax, TDS Range, Visakhapatnam, Andhra Pradesh. The quotations should be submitted in two bid patterns i.e Technical Bid as per Annexure-1 and Financial Bid as per Annexure-II (attached). Both the bids in the prescribed format along with required documents as prescribed should be placed in separate envelopes and sealed and superscribed as "Tender for Hiring of Operational Vehicles - Technical Bid" and "Tender for Hiring of Operational Vehicle - Financial Bid" respectively. Both the envelopes should be placed in a single cover and superscribed as "Quotation for hiring of Operational Vehicle" and the tender documents should be dropped in the drop-box kept for the purpose at the O/o the Addl. Commissioner of Income Tax, TDS Range, Visakhapatnam. Initially, the technical bids will only be opened. The financial bids will be opened only, if the applicant tenderer is selected in the technical bid qualifying in all aspects as per the eligibility criteria and evidence to thereof enclose to the technical bid. Rates quoted should be inclusive of all taxes.

The monthly rent will not be more than Rs. 50,000/- (exclusive of taxes) including all expenses like driver's salary, diesel, maintenance, repairs etc.

**TERMS & CONDITIONS :**

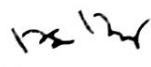
1. The vehicle should not be a old vehicle and should not be more than one year old vehicle and should be in proper running condition and must have a valid taxi permit to run within and outside the state of Andhra Pradesh.

2. The vehicle shall be at the disposal of the income Tax Department for all the days of the month. The vehicles shall be parked at the parking Place of the respective building where the office is situated.
3. The vehicle should be provided along with the driver and fuel. The vehicle supplier shall ensure that driver is made available along with vehicle for all the days of the month.
4. The department is not responsible for any repairs and maintenance of the vehicles. No other charges except the hire charges will be borne by the department.
5. The vehicle has to travel for operational purpose subject to minimum of 2000 kms in month. If the kms agreed upon ( as per the agreement) are not utilized by the Department in any month, the unused kms will be carried forward to the next month.
6. The contractor will be responsible for loss/damage to property or life because of negligence of driver or poor maintenance of vehicle or due to an accident. The department would not be responsible for loss/damage to property or life on account of such incidents.
7. The vehicle should be maintained in a neat, clean and in a perfect running condition.
8. The vehicle should have unlimited passenger liability insurance. All the claims arising out of any accident shall be met by the vehicle provider.
9. The driver should have a valid driving license, should wear proper and clean uniform as prescribed by the RTA and should follow traffic rules and other regulations prescribed by the Government from time to time.
10. The driver must observe all the etiquette and protocol while performing the duty and should carry a mobile phone in working condition.
11. The vehicle provider should arrange for an alternative suitable vehicle, at his own cost, immediately in case of break down of the vehicle supplied.
12. In case of failure to provide alternative suitable vehicle, hire charges on pro-rata basis shall be deducted from the monthly hire charges.

13. Changes of vehicle and the driver should be allowed only in exceptional circumstances.
  14. The monthly hire charges are subject to statutory deductions, like Income Tax etc.
  15. The department reserves the right to terminate the contract with one month notice.
  16. In case the supplier wants to withdraw the contract, he has to give 3 months notice.
  17. No additional charges will be paid for extra mileage and overtime.
  18. The department reserves the right to cancel/suspend the tender process without attributing/giving any reason.
  19. The owner or the driver on behalf of the owner shall maintain a daily log book in respect of the vehicle by recording therein all the necessary particulars including the particulars of starting and closing time of travel, the places travelled and the extent of travel undertaken, with the kilometer reading etc.,
  20. The supplier of the vehicle shall not give the said hired vehicle to any other third party during the subsistence of the present agreement.
  21. The period of contract for hiring of vehicle contract will be from 01.09.2019 to 31.03.2020.

The parties/travel agencies those who are willing for the above terms and conditions may furnish their quotations giving the details of mileage to be given per month subject to minimum of 2000 kms on or before 21.08.2019 at the office of the Additional Commissioner of Income Tax, TDS Range, 1<sup>st</sup> floor, Aayakar Bhavan, Dabagardens, Visakhapatnam.
