ORDER

Pursuant to the O.M vide F.No. HRD/CM/122/04/Steno-I/2019-20/2302 dt. 06.07.2022, the posts of Stenographer Grade-I and erstwhile Stenographer Grade-II in the pre-revised scale of Rs. 5500-9000 and 5000-8000 respectively are hereby merged as Stenographer Grade-I, in Pay Level-6 of Pay matrix as per 7th CPC.

2. The post of Stenographer Grade-III, Pay Scale as per 5th CPC 4000-6000 is hereby re-designated as Stenographer Grade-II, in (PB-I, 5200-20200 with Grade Pay of 2400/-), Level-4 of Pay Matrix, as per 7th CPC.
